The Electronic Statement of Votes cast were unlocked on 28th September 2017 around 15.37 Hours in the presence of two witnesses, namely Ms. Sowmya R and Ms. Vanitha R who are not in the employment of the Company. They have signed below in confirmation of votes being unlocked in their presence. A statement to the effect that the aforesaid persons were witness to the unlocking is also attached in **Annexure-1**.

At the Annual General Meeting, the Company facilitated the members present in the meeting who could not participate in the e-voting to record their votes through the poll process. For details kindly refer to Scrutinizer Report in Form MGT 13 dated 28th September2017.
